Riva Pocha has a master's degree in forensic science from John Jay College of Criminal Justice, New York, and a master's degree in biochemistry from Wilson College, Mumbai University, India. She is a consultant and a forensic educator with over 24 years of training experience in the field. She specializes in consultancy pertaining to crime scene investigation, DNA forensics and forensic toxicology (including alcohol-related incidents).

As the founder of FACTS, her vision is to build a bridge between forensic science and the law, while providing the country with accessible quality forensics in the private domain. She remains clear on her objective to contribute to society in the form of awareness building so as to drive social change / reform. In her efforts to build forensic awareness in community she has been invited to conduct trainings at the Maharashtra Judicial Academy, Bombay Bar Council, Bombay Press Club, and Mumbai Police. In the corporate sector, Riva has developed technical training programs for financial institutions in questioned document analysis and has worked with HR departments in upskilling professionals using team building and skill development forensic programs.
